

## **COSTESSEY PARISH CEMETERY, LONGWATER LANE, NEW COSTESSEY**

Fees, payments and sums set out below apply where the deceased person is, or immediately before death was, an inhabitant or elector of the Parish of Costessey, or in the case of still born children, where the parent (or one of them) are such inhabitants or electors.

**These fees will be charged during the period 1 April 2009 to 31 March 2010**

### **EXCLUSIVE RIGHTS OF BURIAL**

	£
For the exclusive right of burial, for a period of 70 years	
a) in a grave not exceeding 9 feet by 4 feet (2.75 x 1.22m)	380
b) in a grave not exceeding 8 feet by 3 feet (2.44 x 0.9m) for children not exceeding 10 years in the area of the Cemetery set aside for children	240
c) for the burial of cremated remains in the section of the Cemetery set aside for that purpose	170

### **INTERMENTS**

For the interment in a grave in respect of which the exclusive right of burial has been granted:-

a) of the body of a still born child (or children in the same coffin), or of a child whose age at the time of death did not exceed 12 months in the area of the Cemetery set aside for the burial of children	90
b) of the body of a child whose age at the time of death did exceeded 12 months but did not exceed 10 years	125
c) of the body of a person whose age at the time of death exceeded 10 years	200
d) of cremated remains in the section of the Cemetery set aside for that purpose	140

**PLEASE NOTE:** Children up to the age of 12 years can be buried in the area set aside for children.

## **BURIAL WITHOUT THE PURCHASE OF EXCLUSIVE RIGHTS**

For the interment in a grave in respect of which no exclusive rights of burial have been granted:-

a) of the body of a still born child ( or children in the same coffin), or of a child whose age at the time of death did not exceed 12 months in the area of the Cemetery set aside for the burial of children	125
b) of the body of a child whose age at the time of death did exceeded 12 months but did not exceed 10 years	200
c) of the body of a person whose age at the time of death exceeded 10 years	380
d) of cremated remains in the section of the Cemetery set aside for that purpose	140

## **HEADSTONES, TABLETS AND INSCRIPTIONS**

For the right to erect or place on a grave in respect of which exclusive rights of burial have been granted:-

a) a headstone not exceeding 3 feet (0.9m) in height	125
b) a cremation tablet not exceeding 1 feet 6 inches (0.45m) by 1 feet 3 inches (0.38m)	70
c) an inscribed vase	70
d) an additional inscription	70

## **MISCELLANEOUS**

PLEASE NOTE; 'The fees quoted above are for residents of the Parish of Costessey. All non-residents will be charged at double the fees quoted above except where the deceased person was a resident of Costessey for 20 years or more and moved from the Parish within the last 5 years to recognised sheltered accommodation or residential care.
