**COSTESSEY TOWN CEMETERY, LONGWATER LANE, COSTESSEY**  
Fees to be charged during the period 01/04/2021 to 31/03/2022

Fees, payments and sums set out below apply where the deceased person is, or immediately before death was, an inhabitant or elector of the Town of Costessey, or in the case of still-born children, where the parent (or one of them) are such inhabitants or electors.

### EXCLUSIVE RIGHTS OF BURIAL (FOR 70 YEARS)

a) <b>Casket plot</b> - grave not exceeding 9 feet by 6 feet (2.75m x 1.83m), in the section of the cemetery set aside for casket burials	946	950
b) <b>Coffin plot</b> - grave not exceeding 9 feet by 4 feet 6 inches (2.75 x 1.37m)	585	585
c) <b>Cremation plot</b> in the section of the Cemetery set aside for that purpose	234	235
d) <b>Burial or Cremation plot – Under 18 years old at time of death</b> *Fees are recoverable from the Children’s Funeral Fund for England	250*	250*

**Please note: An area of the cemetery is set aside for children under 12 years old for a coffin not exceeding 8 feet by 3 feet (2.44 x 0.9m)**

**PLEASE NOTE:** The fees quoted above are for residents of the Town of Costessey.

**Non-residents will be charged at triple the fees quoted above, EXCEPT where the deceased person was a resident of Costessey for 20 years or more and has moved from the Town within the last 5 years to recognised sheltered accommodation or residential care OR if the interment is into a previously purchased plot, when the Costessey rate applies.**

### **GRAVEDIGGER'S FEES:**

**Costessey Town Council does not employ its own grave digger, so digging fees will be in addition to those quoted above. Arrangements and payment of fees to the Council's authorised grave digger must be via the Funeral Director.**
