## Request for funding assistance for the "Well-BEE-ing Garden"

Early in November 2021, I wrote to Costessey Town Council requesting that they could match-fund the £5000 that my application for Saffron Community Grant funding towards the Well-BEE-ing Garden had achieved.

Since my other bid for the National Lottery "Places Called Home" for the additional £5000 required to complete the installation of the eight hexagonal bed design had been unsuccessful, this had left a shortfall of £5000 in our budgeted costs.

However, with the necessary permission from Saffron, the decision was made to proceed with construction of that part of the garden for which sufficient funding was available, and a unit of three hexagonal beds was ordered from Bear and Co, with the remaining five beds being delayed until sufficient extra funding had been secured. Through liaison with Mr Bear, the bed size was reduced marginally to achieve a more aesthetic visual result and by doing so, a reduction in cost per unit was achieved. Later, in December, a further £1000 was secured through the South Norfolk Council Ward Member's Grant donated by Councillor Dan Burrell. This extra funding enabled me to order a further two hexagonal beds which would result in a more substantial construction, although still short of the full design. Since November, we have also set up a successful sociable Community Gardening Club which continues to attract new members of different ages and gardening expertise. One group from the club have since refurbished the neglected raised bed by the Library in Breckland Park, and this promises to provide a stunning spring display.

The five ordered beds are almost ready for installation later in January/ beginning of February and will then be filled with soil in preparation for early springtime planting. Due to the marginal reduction of the bed size with the consequent reduction in cost, as well as the December funding boost by Councillor Burrell, the shortfall to complete the design has greatly reduced from my November request of £5000 to £2500.

Should CTC be able to contribute this remaining £2500, it would enable the remaining three beds to be built and installed at the same time and for the complete installation to be filled with soil. This would avoid further disturbance by a later installation and would allow the complete "Well-BEE-ing Garden" to be planted by the Club members early this spring, many supplying suitable plants freely from their own gardens. The result: a stunning nectar-rich, pollinator-friendly display to celebrate the Platinum Jubilee of Her Majesty, as well as a restful, calming environment for our less active elderly and disabled residents for this and for years to come. Additionally, the garden will not only extend the Bee Corridors through Costessey but will also be of considerable educational benefit to our residents and schools, demonstrating which plant species they can introduce into their own gardens to help support our endangered pollinators.

	C FREEMEN AND HONORARY FREEMEN
	5.15 The LGA 1972 did not affect any person's status as, or his right to be admitted to the status of, a freeman of a previously existing borough. The freemen's roll is kept by the district council (T), whose chairman must examine and decide claims to be admitted. The Act also expressly preserved the special rights of freemen, their appropriate relatives or associates, the relatives by marriage of their widows or children and of existing or future inhabitants in any property or otherwise <sup>1</sup> .
*	A local council and charter trustees may admit as honorary freemen or honorary freewomen persons of distinction and those who have rendered eminent service to the place or area <sup>2</sup> . This must be done at a meeting specially convened for the purpose and requires a two thirds majority of those voting. Such honorary freedom carries none of the special rights preserved by the Act <sup>3</sup> .

	(5) Subject as follows, a relevant authority may admit to be honorary freedom honorary freewomen of the place or area for which it is the authority—  (a) persons of distinction, and (b) persons who have, in the opinion of the authority, rendered conservices to that place or area.  (6) In this section "relevant authority" means—  (a) a principal council; (b) a parish or community council; (c) charter trustees in England constituted—  (i) under section 246 of the Local Government, Act 1972, (ii) by the Charter Trustees Regulations 1996, (SL 1996263), or (iii) under Part 1 of the Local Government and Public Involvement Health Act 2007.  (7) The power in subsection (5) above is exercisable by resolution of the relevant authority.  (8) A resolution under subsection (7) above must be passed—  (a) at a meeting of the relevant authority which is specially convened to purpose and where notice of the object of the meeting has been given by not less than two-thirds of the members of the relevant authority in the case of charter trustees, of the trustees) who wore on it.  (9) A relevant authority may spend such reasonable sum as it thinks fit to purpose of presenting an address or a casket containing an address to a person whom the authority has conferred the title of honorary freeman or honorary freewoman under subsection (5) above.
